REGISTRATION & DEPOSIT:

To register for this tour, please send the completed booking form to the BirdsConTour office. We will then send you the banking details.
The initial deposit for this tour is 50% of the tour cost per person. If you would like to pay your initial deposit by money order, or bank transfer, your tour space will be held for 10 days to allow time for the BirdsConTour office to receive your deposit and completed registration form. If you prefer to pay the initial deposit using a credit card, your deposit must be made with MasterCard or Visa at the time of registration.

PAYMENTS:

Initial tour deposits may be made by MasterCard, Visa, or bank transfer. All other tour payments, including second deposits, interim payments, final balances, special arrangements, etc., must be made by money order, or bank transfer (contact the BirdsConTour office for bank transfer information). Full payment of the tour fee is due 120 days prior to the tour departure date.

Trip Cancellation & Medical Emergency Insurance

We strongly recommend you consider purchasing trip cancellation (including medical emergency) insurance to cover your investment in case of injury or illness to your family prior to or during a trip. Because we must remit early (and substantial) tour deposits to our suppliers, we cannot offer any refund when cancellation occurs within 30 days of departure, and only partial refund from 30 to 42 days prior to departure (see cancellation policy).

Responsibility

BirdsConTour accepts no responsibility for losses or additional expenses due to delay or charges in air or other services, sickness, weather, strike, war, quarantine, or other causes. The tour participant shall bear all such losses and expenses. BirdsConTour reserves the right to substitute hotels or similar category for those indicated and to make any changes in the itinerary where deemed necessary or caused by changes in air schedules. BirdsConTour reserves the right to decline to accept or to retain any person as a member of any tour. Baggage is at owner's risk entirely.
