RATES ARE

- Inclusive of 15% vat
- · Invoiced and payable in ZAR
- · Quoted per room per night based on a maximum of 2 adults
- There is no single person rate and no third adult in a room.
- · Subject to availability
- · Subject to change without prior notice.

RATES INCLUDE

- Luxury accommodation
- Breakfast
- Tea/coffee
- · All beverages such as soft drinks, waters, house wines, beers, ciders and selected spirits

RATES EXCLUDE

- Lunch and Dinner
- Premium wines and champagne on wine list
- Premium and craft spirits and single malt whiskeys
- Transfers
- Gratuities
- Laundry services

CHILD POLICY

- · Children 6 years and older are welcome at Last Word Franschhoek
- · Should the entire hotel be booked for a group then children of all ages are welcome
- · Children from 12 years and older are considered adults and will have to take their own room at the applicable rates
- · Children between the ages of 6 and 11 years may share with parents in the following room categories: Pool Suite,
- Children sharing with their parents will be charged R2 200 per night per child (net rate) up to a maximum of 2 children (subject to availability)

GUIDE POLICY

Should drivers/guides be required to stay at Last Word they will be required to pay the applicable room rate and this is
subject to availability

MINUMUM STAY DURING SEASON

• A minimum night stay of 2 nights are required between the dates 20 December and 15 February in Franschhoek

DYNAMIC / BAR RATES

· Last Word reserves the rights to implement dynamic/bar rates 90 days prior to check-in date

BOOKING PROCEDURES

- · All reservations must be made by email directly to Last Word Reservations stay@thelastword.co.za
- Should you not receive a written response to your request then please assume that it was not received and resend the request as a booking was not made
- · Please note that all cancellations and/or amendments must also be in writing

PROVISIONAL POLICY

- · Subject to availability should we have limited suites available only confirmed bookings will be accepted
- Provisional reservations made less than 30 days prior to arrival will be held for 48 hours
- · Full names of guests travelling will be required to convert the status from provisional to confirmed

DEPOSIT AND PAYMENT POLICY

Tour Operators

- Full payment is required 30 days prior to arrival
- · Reservations not paid 30 days in advance will be cancelled on notice to the agent
- Voucher numbers will not be accepted as guarantees for bookings
- Tour operators electing to settle a booking with a credit card will be subjected to a 5% surcharge
- · Deposit conditions may be waivered for bookings from the trade, tour operators and agents
- All extras are to be settled at the property on departure
- 10% deposit required on group bookings non refundable

Direct Bookings

- 50% Deposit is required on confirmation
- Full payment is required 30 days prior to arrival
- · Reservations not paid 30 days in advance will be cancelled on notice to the guest
- · All extras are to be settled at the property on departure

Online Bookings

- 50% Deposit is required on confirmation
- · Final payment required on date of check in.
- All extras are to be settled at the property on departure

CANCELLATION POLICY

- Only written cancellations will be accepted. Ensure to receive an acknowledgement of cancellations in writing by Last Word Reservations
- 50% of full amount if cancellation is within 30 45 days prior to arrival
- 100% of full amount if cancellation is 30 days or less prior to arrival
- · Cancellations for medical reasons must be part of travel insurance taken out by the client
- In the event of early departure the full extent of the stay as originally booked and confirmed will be charged

TRAVEL INSURANCE

· We insist that travel insurance is taken out on all bookings

ARRIVAL AND DEPARTURE

- Guests may check in from 14h00
- Rooms are to be vacated by 11h00

TRANSFERS

· Road transfers can be arranged on request at an additional charge.
