



Booking Terms & Conditions 2022-2023

Booking confirmation and payment

 $On sea \ House \ Tanzania \ Ltd \ accepts \ provisional \ bookings \ through \ email \ on \ reservations @on sea house.com$

Booking confirmations only after email confirmation on reservations@onseahouse.com .

No deposit required at the time of booking confirmation

Full payment should be done 30 days prior to guest arrival, unless otherwise agreed

For bookings within 30 days prior to arrival, 100% payment should be made within 5 days or the booking will be cancelled. If agreed in advance, payments of reservations can be combined and settled once a month with remittance advise

Onsea House Tanzania Ltd reserves the right to refuse bookings at its discretion

Cancellation policy

From confirmation to 61 days prior to arrival, you can cancel without cancellation fees

From 60 to 31 days prior to arrival, 30% cancellation fees are charged*

From 30 to 3 days prior to arrival, 75% cancellation fees are charged*

*unless Covid-19 related travel restrictions in place at time of travel: postponement allowed until end 2023.

No refund is made in case of cancellation within 3 days of arrival or in case of non-arrival without cancellation.

Provisional Bookings / Block Bookings

All provisional Bookings need to be confirmed or cancelled ASAP.

Due to the size and nature of Onsea House and Machweo, we strongly refrein block bookings.
