Apoka Safari Lodge is located on a picturesque Kopje overlooking the Narus Valley in the southwestern sector of Kidepo Valley National Park – Uganda’s most remote park. Kidepo presents an amazing wildlife experience with pristine wilderness in abundance. Lions, leopards, cheetahs (only park in Uganda with cheetahs), elephants, giraffes, zebras, ostriches, and possibly Africa’s largest herds of buffalos as well as rarities such as the tantalus monkey. The vast golden green plains are punctuated with craggy, rocky outcrops, revealing an even bigger sky at night. Under a canopy of impossibly bright stars, this is where we are reminded that the Earth is round. Apoka Safari Lodge is relaxed and appropriately located in the park bringing you a peaceful and private experience.

#### DAY VISITS

Day visits can only be booked in advance and we reserve the right to refuse a booking. Since Apoka Safari Lodge is located within the park, please note that the Uganda Wildlife Park fees apply and are not included in the rates below;

Adults: \$80 per adult  
Child: \$45 per child



## FLIGHTS

The closest airstrip to Apoka Safari Lodge is Kidepo Airstrip which is a +/- 10-minute drive from Apoka per way. Flights to Kidepo airstrip are charged per way and only operate with a minimum number of passengers.

In cases where the minimum number of passengers is not met, guests must pay for the extra seats. Two major airlines fly to Kidepo i.e. Kampala Executive Aviation (KEA), which operates out of the Kajjansi airstrip, requires a minimum of 3 pax. They use the Cessna 210, Cessna 206, or Cessna 172 for their flights. Their flights operate in the morning. If a guest would prefer to fly out and land in Entebbe instead of Kajjansi, they must pay a surcharge fee per way.

With KEA, passenger luggage is limited to 10kgs per passenger in soft bags. Maximum size of 25cm x 30cm x 60cm.

Aerolink Uganda, which operates out of Entebbe International Airport, requires a minimum of 7 pax. They use the Caravan 208 and their flight operates mainly in the mid-morning/afternoon.

Passenger luggage is limited to 15kgs per passenger inclusive of carry-on bags. Luggage should have the three dimensions of 24 inches (60 cm) height by 18 inches (45 cm) length by 13 inches (33cm) width. For hand luggage, 12 inches (30cm) height by 21 inches (53cm) length by 9 inches (23 cm) width.

Charter options are also available from both airlines depending on availability. Please contact our reservations team for more details.

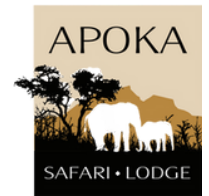
