Waiver & Indemnity

I, the undersigned, do hereby unto and in favor of Kamba African Rainforest Experiences (Pty) Ltd, their holding, sister, subsidiary, and associated companies, and each and every shareholder, director, employee, agent, and representative of Kamba African Rainforest Experiences (Pty) Ltd and their holding, sister, subsidiary and associated companies, individually and collectively, including “Kamba Lodges” in the Republic of Congo:

1. Acknowledge that I am entering on safari into a wildlife area, that I will be traveling by vehicle over uneven and potentially hazardous terrain, that I will be staying in an unfenced lodge, and that my venture on safari may take or bring me into close contact with wild and dangerous animals;
2. Acknowledge that my venture on safari, including all traveling to and from and within the wildlife areas, is entirely at my own risk;
3. Confirm that I fully appreciate the nature of the risks I will be exposed to whilst participating in the activities;
4. Release Kamba African Rainforest Experiences (Pty) Ltd from all and any liability and waive all and any claims, of whatsoever nature and howsoever arising, which may arise from any cause whatsoever during the period of my venture on safari, including all traveling to, from, and within any wildlife areas;
5. Indemnify and agree to hold harmless Kamba African Rainforest Experiences (Pty) Ltd against all and any claims of whatsoever nature and howsoever arising from any cause whatsoever during the period of my venture on safari, including all traveling to, from, and within any wildlife areas, which any one or more of dependants or any third party may have, including, but not limited to, claims arising from my death, personal injury or loss or damage to my possessions;
6. Agree to adhere to all regulations which may be brought to my attention during the period of my venture on safari, either by management, guides, or any other employee of Kamba African Rainforest Experiences (Pty) Ltd, Kamba Lodges;
7. Without derogating from the generality of the foregoing, acknowledge that Kamba African Rainforest Experiences (Pty) Ltd shall not be liable to me or any of my dependents, relatives, or guests for any injury, illness, harm, loss of support, consequential loss, damage, or damages of whatsoever nature that may be sustained from any cause whatsoever (including but not limited to negligence and/or fault) during my venture on safari, including all traveling to and from within the wildlife areas.

Acknowledge and agree that any claims, be they in contract, delict or otherwise, instituted against Kamba African Rainforest Experiences (Pty) Ltd shall be governed by the laws of the Republic of South Africa and may only be instituted in a South Africa court to the exclusion of all other jurisdictions.
