BOOKING PROCEDURE

TONGABEZI AND SINDABEZI RATES INCLUDE:

Included Activities available on normal rates:

Park fees are charged at ZMW100 per person per visit (subject to change)

Museum entrance is ZMW 25 per person (subject to change)

Please note for non-inclusive activities there is a private vehicle transfer charge of US\$ 25 per outing.

Guests requiring a private vehicle for their activities will be charged \$100.00 per vehicle per day (subject to change).

GROUPS

Groups are welcome at Tongabezi and a special rate applies for groups wishing to take Sindabezi Island privately. Group discounts at Tongabezi will only be considered in low season. For groups of more than 5 pax a 25% deposit is required to confirm the booking. If the number of guests in a group reduces after confirmation, cancellation charges will apply in full and will be deducted from the deposit.

CHILDREN POLICY

Tongabezi: We are happy to take children of seven and over. Children under 14 pay 50% unless they are in their own room.

Sindabezi: We are happy to take children of 14 and over, charged adult rates. If the island is taken privately we are happy to take children of seven and older. In this case children under 14 pay 50% unless they are in their own room.

Tangala: Children of any age are accepted at Tangala and two of the staff members are experienced nannies. Please note that there is an unfenced swimming pool. We can arrange a safety fence on request for non-swimmers. Children under 14 are charged 50% of the full board rate. Tangala comes with 3 friendly dogs.

TERMS AND CONDITIONS

All prices are quoted and payable in United States Dollars

Tongabezi will hold provisional bookings for 15 days ONLY

Provisional bookings for guests arriving within 6 months from the booking date will only be held for 7 days.

Bookings for arrivals due within 3 months should be confirmed within 48 hours

All transfer costs incurred due to late notification of arrival or departure times will be for the account of the booking agent.

Bookings must be confirmed with transfer details.

All bookings for Tangala will be confirmed with a 25% deposit

All group bookings will be confirmed with a 25% deposit

All prices are subject to change

CANCELLATION POLICY

PLEASE NOTE THAT THE FULL CANCELLATION POLICY APPLIES THE MOMENT YOU CONFIRM A BOOKING TO US – PLEASE ENSURE THAT YOU HAVE A DEPOSIT FROM YOUR CLIENT TO COVER THESE COSTS

Cancellations are only effective if the agent has received a written reply acknowledging the cancellation—it is the responsibility of the agent to ensure that Tongabezi acknowledge a cancelled booking.

At Tongabezi we are not keen on billing people for **not** staying with us. We will therefore **never** charge 100% cancellation fees!

Unfortunately cancellation costs to the lodge are as much a reality as taking out travel insurance will be to our visitors.

When it happens that you have to cancel your booking we would therefore like to advise you of the following policies that are in place:

If you are holding a confirmed booking and you then inform us that you will not travel.

- 60 days or more before arrival we will charge THE BOOKING AGENT 25% of RACK rates
- Between 30 and 60 days before arrival we will charge THE BOOKING AGENT 50% of RACK rate

We accept that cancellations done 30 days or less before arrival are due to unfortunate and unavoidable circumstances for our clients.

So for late cancellations we have changed the rules a bit:

The cancellation charge TO THE BOOKING AGENT remains 50% of RACK rate and if the guest decides to rebook at any time during the subsequent 12 months (for bookings made in the same season as the original booking) we will only charge 50% of RACK for the new booking!!

PAYMENTS

All bank charges up to Zambia are at the cost of the sender.

Full payment must be made no later than 30 days prior to the guest's arrival unless agreed otherwise.

Remittance Advise need urgently to be faxed/emailed for correct payment to invoice allocation to reconcile your account accordingly.

Refunds are offset against future bookings. If you prefer bank transfers, a bank fee will be charged at your cost

Any refunds due if not set off against future bookings are subject to Zambian Bank transfer charges.

Overdue accounts will be charged with a monthly 5% interest until payment is made.

Overdue accounts will have their commission rates reviewed

Discrepancies should not delay payment of approved invoiced amounts.

Discrepancies to be indicated within 30days and emailed/faxed to the accounts department for reconciling, then included in the following months payment

Prices of activities are subject to change without notice should operator's prices increase

All payments to be received into our Zambia account at the US\$ invoiced amount
