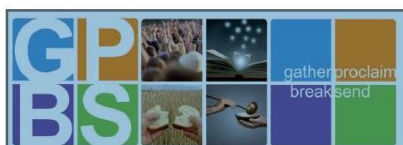

Conditions:

The tour prices are based on airfare, general transport, accommodation and other costs at foreign exchange rates at 1 May 2019. GPBS and Minna Travel & Cruise reserves the right to alter the tour price or modify the tour if any of these factors change, giving any passenger that has booked the right to withdraw with a full refund of monies paid if the price increase is greater than 10% than the original price. No alteration to the tour price will be made within 60 days of departure from Australia.

Changes:

After confirmation of travel arrangements, no change to travel arrangements or names will be allowed without fee. All changes to will incur a fee of \$55 for each change plus any other expense occurred by the change.

Cancellation Charges:

Cancellation before 01 Dec 19 will incur the full deposit of \$3,000 penalty and after this date will result in the loss of all monies paid or partial payment depending on circumstances and date of cancellation. Travel insurance would cover most of these costs depending on the circumstances and type of cover taken.

Refunds:

This tour is based on arrangements that do not allow for any refunds in respect to sightseeing, accommodation, meals, airfare or other services not utilised after the tour has commenced.

MINIMUM TOUR NUMBERS AND CONDITIONS:

The fully escorted part of this tour has been based on a minimum number of passengers having booked by 120 days prior to the date of departure. Minna Travel & Cruise reserves the right to revert the tour to a locally escorted tour. Under other safety circumstances the tour could be cancelled, and refunds may be due for all or most of the trip and the remainder may or may not be covered by your insurance.

Travel Documents:

All passengers will need to be in possession of a valid passport with at least 6 months validity after the return date of travel (e.g. 23 Oct 20 or later).

Travel Insurance:

Baggage:

All economy class passengers qualify for 23kg free baggage allowance (on some airlines 30kg are allowed).
