Photo identification is required for domestic flights, Children/Infants under 12 years require Birth Certificate or U5 Vaccination Card if no photo ID. Domestic check-in closes strictly 30 minutes before departure. International check-in closes strictly 40 minutes before departure. No passengers accepted for travel after check-in has closed. Passengers are considered no-shows and bound to the fare rule of their ticket regarding no-shows.
