- 2. This program is issued on the sole responsibility of the Company and has been compiled with reasonable care. It is not issued on behalf of, and does not imply endorsement by any airlines whose flights form part of the tour arrangements. Considerable care has been taken to compile the information in this brochure but circumstances beyond our control may necessitate changes in itinerary or hotels.
- 3. Completion and signing of the Booking Form will be taken as an understanding by the Company that the participant has read and agrees to abide by these terms and conditions.
- 4. The balance of payment as set out in the confirmation invoice is due no later than sixty days prior to departure.
- 5. After confirmation of the booking the following amendment charges will apply. Amendments cannot be made less than 21 days prior to departure:-
 - Prior to issuing of documents: \$50.00 per person per amendment
 - After issue of documents: \$150.00 per person per amendment
- 6. After confirmation of the booking the following cancellation charges will apply in the event of cancellation. Advice of cancellation must be made in writing to the Company:-
 - If the cancellation is made more than 45 days prior to departure: loss of deposit only
