Booking Conditions

The deposit or full balance payment subscribes the following booking conditions.

Reservations

A 30% deposit for safari is required at the time of booking with the balance to be paid at least 60 days before the tour begins.

Payments: wire transfer or credit card (5%) commission extra charged on top of the price for credit cards).

Airline schedules may change and flights may be delayed or cancelled for a range of reasons including but not limited to bad weather, air traffic control delays, strikes, technical disruptions, network changes and late inbound aircraft. Accordingly, Savannah Explorers does not guarantee that the airline will be able to carry you and your baggage in accordance with the date and time of the flights specified in your booking and is not responsible for any flight change/delay/cancellation.

Cancellations

Prior to tour departure, for cancellations received by us in writing:-From booking time to 91 days prior the tour starts: cancellation fee 250 usd per person.

From 90 to 60 days prior the tour starts: 30% deposit paid is not refundable. 60 days or less or no show: 100% tour price.

There are no refunds for unused portions of the program, and refunds will not be made to clients who do not complete the tour for any reason.

Whatever amendments made to the itinerary once paid may result in additional costs.
