Changes:

Travel insurance is compulsory to cover the costs of cancellation fees due to illness, death in family, illness while overseas and any accidents etc. See also responsibilities below.

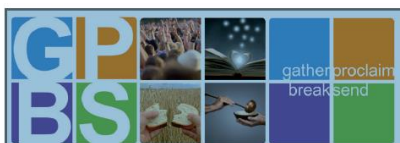
Changes to the tour itinerary:
