## TERMS & CONDITIONS:

### 1. Booking Conditions

- 1.1 All tours are operated and bookings accepted by Mainline Sports Tours CC, hereafter referred to as SA Sports Tours™ or SAST.
- 1.2 Dates, prices and itineraries shown for tours are subject to change and confirmation.
- 1.3 SAST reserves the right to make alterations to a tour without notice, including alterations to the itinerary.
- 1.4 The decision of the tour leader will be final on all matters relating to the satisfactory progress, organization and well-being of the tour. Clients must comply with all reasonable requests of the tour leader.

### 2. Payments

- 2.1 The tour price is made up of 3 part-payments:
  - 30% payable 9 months prior to touring
  - 30% payable 6 months (180 DAYS) prior to touring
  - 40% payable 2 months (60 DAYS) prior to touring
- 2.2 A non-refundable 1<sup>st</sup> deposit of 30% of the tour price is payable in respect of each person 9 months prior to the tour date.
- 2.3 The 2<sup>nd</sup> 30% payment is to be paid 6 months prior to the tour date. This will be used to pay accommodation, transport and any other service providers that require deposits in order to secure bookings.
- 2.4 The 40% balance of the tour price is payable no later than 2 months (60 days) prior to the tour date provided in the Booking Form.
- 2.5 If full payment is not received 2 months prior to the tour date, SA Sports Tours™ shall deem the booking cancelled and an additional 30% of the tour price shall be forfeited (over & above the initial 30% non-refundable deposit) due to services already paid for.
- 2.6 Cancellation of a booking must be done in writing / email. Cancellation charges are as follows:

PERIOD BEFORE DEPARTURE	% OF TOUR PAYABLE
FROM BOOKING	30% OF THE TOUR PRICE
FOR CANCELLATION 90 DAYS OR LESS	60% OF THE TOUR PRICE
FOR CANCELLATION 30 DAYS OR LESS	100% OF THE TOUR PRICE

- 2.7 All bank charges for cash deposits / tour payments received are for the clients account.
- 2.8 Full banking details appear on this booking form. Please email or fax proof of payment when done.

### 3. Liabilities

- 3.1 In the event of any person leaving the tour of their own accord, or in extenuating circumstances being asked to leave tour by the tour leader, that person will be liable for their own maintenance and expenses and will have no claim against SAST whatsoever.
- 3.2 No authorized representative of SAST has authority to commit SAST to any liability whatsoever, and SAST will not be bound by any statement or representation unless it is in writing and signed by one of the directors.

- 4.1 SA Sports Tours™ are SATSA BONDED with third party indemnity, ensuring financial peace of mind.
- 4.2 SA Sports Tours™ guarantees not to levy any surcharges on the tour price once the part-deposit has been received.
